Following points were discussed

1. Gram Vikas Adhikari Shree Kumbhar ji expressed gratitude for attending the meeting organized by Gram Panchayat Wagholi and appealed every society to take extra precaution to stop Covid19 spread by:
 - a. Sanitization by Societies as much as possible in all corners of society including common areas and lifts.
 - b. Washbasin and Sanitization provision in society premises for hand sanitization.
 - c. SPOs are requested to be more careful and be helping hand to society residents.
 - d. Property tax is due and he requested everyone to pay online as early as possible which will help to strengthen the preventive measures in corona spread prevention.

- e. Information of residents going out of the Wagholi for Office work to be shared with GP as early as possible which will be helpful for making the planning for various medicines.
 - f. All societies are requested to keep Sanitization pumps in stock for the purpose of sanitization of their premise.
2. Senior PI Shree Mankar addressed the meeting with request to every resident and SPO to remain alert to prevent further spread of Covid19. Shree Mankar addressed the meeting with following points:
 - a. Total Lockdown is to be imposed from 13th July 2020 to 18th July 2020 for 5 days where only essential services shall be allowed to be opened i.e. only Medical Services.
 - b. He further requested to maximum utilize local area shops for purchasing items instead of going far out. This will reduce point of contact from outside.
 - c. Additional precautions should be taken for senior citizens and to be consulted immediately to doctor in case of emergency.
 3. WWSA presented and read out a memorandum of suggestions to all authorities with request to think on Theme line **“My Wagholi - My Pride - My Responsibility”**. Detailed Suggestions are attached herewith for reference.
 4. Mr. Mankar responded to all queries of residents.
 5. Further Ex ZP Member Shree Chandrakant Kolte addressed the meeting with following points:
 - a. He requested everyone to increase the immunity and Will Power to fight against Corona.
 - b. Mr. Kolte quoted **“We are Working for Our Society”**, to be upheld if we want to win this war against Corona.
 - c. He requested everyone to help administration to fight against Corona.
 6. Ex ZP Member Shree Rambhau Dabhade further addressed the meeting with following points:
 - a. Shree Dabhade urged everyone to be co-operative to fight against corona with mutual bonding.
 - b. He briefed about the past lockdown work that all Wagholikars did which made Wagholi model to be used in other villages across India.
 - c. Further Shree Dabhade urged to follow guidelines by authorities to prevent Corona spread.
 - d. Further Shree Dabhade requested everyone to share the information of officials working outside of the Wagholi to PHC and GP.
 - e. Society SPO list is to be shared with GP for Better Co-ordination among all.

7. Shree Rahul Khaire, Purvarang, highlighted the issue of difference between the guidelines of DDR (Deputy District Registrar) and Collector and requested to draw guidelines to safeguard society committee who is working in the interest of society. Society Office bearers are playing important role in making citizens follow them.
8. Mr. Paresh Kataria, Aura County, requested to circulate the Orders by the SDO and Collector to each society as few residents frequently ask for the same for any guidelines when framed by the society committee. He highlighted the issue of wages cut during WFH and requested authorities to help them in this regard.
9. Mr. Gugale, Suyog Lucky Homes, requested to increase the frequency of Patrolling by LKPS to ensure adherence to lockdown.
10. Shree Mankar informed that travelling to Wagholi with outstation pass is allowed.
11. Mr. Ankur Mishra, Alfa Landmark, raised the question of Medical Services upon which Shree Mankar replied that Medical Services are allowed in lockdown.
12. Shree Mankar further informed that Intra-District Pass approval authority will be declared by the collector soon.
13. Authorities requested residents to use toll free number of PHC only in case of Emergency.
14. Shree Mankar agreed to do Patrolling to as much area as possible.
15. Shree Mankar further stressed on self-discipline while answering residents questions.
16. Rahul Dode, Spandan Sparsh, requested to issue proper guidelines to be followed by each society. Their Society will be sharing the data of all working professional soon to GP.
17. Residents from Grand Vita Society explained the issues being faced by them as builder has not handed over the society and they are totally unaware about the guidelines and orders of Government. They Expressed their gratitude to GP Member Mr. Sandip Satav in helping them.
18. Further, GP Member Shree Ramkrishna Satav addressed the meeting with following points:
 - a. He requested Lonikand Police Station to start help line numbers with operators fluent in all Languages.
 - b. Further Shree Ramkrishna informed about the provision of additional beds in Wagholi with the help of ZP Member Shree Dnyaneshwar Katke.

Ubale informed everyone that medical help has been given to all doctors and PHC and assured to think and implement the suggestions submitted to GP with one Mission **"MY WAGHOLI - MY PRIDE - MY RESPONSIBILITY"**

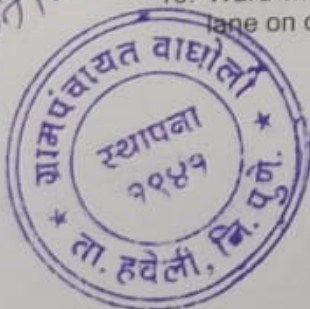
Sub: Wagholi COVID-19 Pattern

MY WAGHOLI MY PRIDE MY RESPONSIBILITY

To prevent the further spread of COVID-19 outbreak in Wagholi, it is the responsibility of every citizen / resident to maintain social distancing norms adhering to Government and Gram Panchayat guidelines. It is our prime responsibility to safeguard ourselves as well as our surrounding from COVID-19.

Following are the points/suggestions from residents of Wagholi:

1. Start Gram Panchayat Toll Free number to tackle the questions and queries by residents and to get all information round the clock.
2. Formation of COVID Control committees ward wise consisting of Ward representatives, residents and chairman and secretary of each society which will monitor the situation round the clock. These committees will report to Main committee at Village Level.
3. Look for the possibility of taking possession of under construction sites, ready possession flats after consulting builders to accommodate symptomatic and asymptomatic patients in case of emergency.
4. Sanitization of affected areas twice a day with the help of concerned societies at least for 7 days.
5. Arranging vegetables at each ward and society twice a week.
6. Taking information from each society and working professional going outside Wagholi for work and provision for their medical checkup with antibiotic medicines.
7. Promote home delivery of Groceries, vegetables, essential items etc.
8. Appointment of Additional SDO in Gram Panchayat office who will observe the situation round the clock.
9. Patrolling in respective areas with the help of Lonikand Police Station, Special Police Officers and Ward members.
10. Ward wise announcement of public awareness about CORONA in each ward and each Wagholi lane on daily basis.

11. Maintain sufficient stock of medicines with the help of Medical Stores.
12. If possible, medical check of senior citizens with the help of Medical Staff.
13. Public awareness about use of Arogya Setu App.
14. Increase number of beds asap in Wagholi for Covid patients.
15. Improve private ambulance services for helping suspect Covid patients.
16. Deploy police at important junctions to stop and penalize vehicles which are not following guidelines for number of passengers and people not following social distancing norms.

ग्रामपंचायत मार्फत सोसायटीमध्ये अंमलबजावणी करणे योग्य, कोरोना प्रतिबंधक मार्गदर्शक अशी अधिकृत नियमावली तयार करण्यात यावी. व त्याचे तंतोतंत पालन करण्याचे निर्देश प्रत्येक सोसायटीला देण्यात यावे तसेच या नियमांची माहिती प्रत्येक सोसायटीतील ग्रामस्था पर्यंत पोहोचवण्यात यावी

वाघोली येथील सहकारी गृहनिर्माण संस्थेतील ग्रामस्थांकडून प्राप्त झालेल्या सूचना खालील प्रमाणे आहेत.

१. ग्रामपंचायत मार्फत २४ तास टोल फ्री हेल्पलाईन क्रमांक सुरू करण्यात यावा ज्याद्वारे ग्रामस्थांच्या विविध प्रश्नांची उत्तरे त्वरित देता येतील तसेच शंका समाधान करता येईल.
२. वार्ड निहाय कोविड कंट्रोल कमिटी चे स्थापना करावी ज्यामध्ये ग्रामपंचायत सदस्य आणि सोसायटीचे चेअरमन सेक्रेटरी आणि रहिवासी यांचा समावेश असावा. सदर कमिटी वार्ड निहाय कोरोना परिस्थितीचा आढावा घेत राहिल. सदर कमिटी गाव पातळीवरील वरिष्ठ कमिटीला वेळोवेळी त्यांच्या वार्डातील करून परिस्थितीबद्दल अद्यावत माहिती पुरवित राहिल.
३. वाघोली परिसरातील अंडर-कन्स्ट्रक्शन इमारती, रेडी पझेसन फ्लॅट इत्यादी चा वापर सौम्य लक्षणे असलेल्या रुग्णांसाठी किंवा अन्य तत्सम इमर्जन्सी परिस्थितीसाठी वापर करता येईल का? याबद्दल बांधकाम व्यावसायिकांकडे चौकशी करावे.
४. कोरोना रुग्ण सापडलेल्या परिसरात सतत सात दिवस दिवसातून किमान दोन वेळा निर्जंतुकीकरण करण्याची व्यवस्था करण्यात यावी.
५. प्रत्येक वार्डात आणि सोसायट्यांमध्ये आठवड्यातून दोनदा भाजीपाला पुरवण्याची व्यवस्था करण्यात येईल.
६. नोकरी किंवा इतर कामधंदा निमित्त वाघोली तुन बाहेर जाणाऱ्या नागरिकांची माहिती गोळा करण्यात यावी तसेच त्यांचे वैद्यकीय तपासणी व गरज भासल्यास औषधोपचाराची व्यवस्था करण्यात यावी.
